

## SECTION 00020 INVITATION TO BID

The City of Gregory, South Dakota, will receive sealed bids for their First Street and Logan Avenue Street and Water Improvements Project until **Wednesday, November 17, 2021, at 2:00 PM** (local time). Bids can be delivered to the Finance Office at 120 W 6<sup>th</sup> Street in Gregory, South Dakota. Received sealed bids will be publicly opened and read aloud at the above time.

The major elements associated with the First Street and Logan Avenue Street and Water Improvements project are approximately:

### **Bid Schedule A:**

- 3160 cubic yards of general street excavation
- 2650 cubic yards of roadway embankment
- 790 cubic yards of salvage and replace topsoil
- 4700 tons of gravel base course
- 1970 tons of asphalt surfacing
- 180 square yards of concrete pavement
- 100 square yards of concrete fillet section
- 3460 feet of concrete curb and gutter
- 92 feet of 12" RCP storm sewer
- 16 feet of 24" RCP storm sewer
- 264 feet of 42" RCP storm sewer
- 4 each 2' by 3' Type B drop inlets with frame and grate
- 130 feet of 6" PVC water main
- 740 feet of 8" PVC water main
- 4 each 6" gate valves with box
- 1 each 8" gate valve with box
- 2 each 4" sanitary sewer taps
- 5 each 1" corporation stop with tapping saddle
- 2 each 1" curb stop with box
- 65 feet of 4" PVC sanitary sewer
- 58 feet of 1" high density polyethylene pipe

The approximate quantities mentioned above are subject to increase or decrease. It will be agreed by bidders that all quantities of work will be performed in accordance with the provisions of the specifications and at the unit price bid. Bidders agree to furnish all labor, material, and equipment necessary to complete all the work as shown in the plans and specifications.

The complete set of Contract Documents, including drawings and specifications, is on file with the Finance Officer, Gregory, South Dakota, and/or at the office of Schmucker, Paul, Nohr and Associates, 2100 North Sanborn Blvd, Mitchell, South Dakota 57301. A paper copy of the contract documents can be ordered with a non-refundable payment of \$50 plus applicable sales taxes. The contract documents and plans will also be made available at the SPN web site [www.spn-assoc.com](http://www.spn-assoc.com) with a non-refundable payment of \$20. Upon request, one copy of the contract documents and plans will be furnished at no charge as required by SDCL 5-18B-1 to each contractor who is a South Dakota resident and who intends to bid the project.

Each bid must be accompanied by a certified check or bank draft payable to the order of the City of Gregory, South Dakota, in an amount equal to five percent (5%) of the total bid. A bid bond in an amount equal to ten percent (10%) of the total bid will be accepted in lieu of a certified check or bank draft. Surety for bid bond must be authorized to do business in the State of South Dakota.

Pursuant to State Law, a copy of the bidder's sales and use tax license and a copy of the bidder's excise tax license as issued by the State of South Dakota must accompany the bid. In lieu of a copy of the license, the bidder shall submit appropriate evidence that the bidder and all affiliates have the appropriate licenses.

Bidders are advised that any contracts awarded on this project will be partially funded by the South Dakota Department of Transportation Community Access Road Grant and by the City of Gregory.

Bids may be held by the City Council for a period of not more than thirty (30) days from the date of opening of bids for the purpose of reviewing the bids, investigating the qualifications of the bidders and completing financial arrangements prior to awarding the Work. The Owner reserves the right to reject any or all bids and to waive any informalities in the bidding and make awards to the Owner's best interest.
